Min 1/12/06/2023: Preliminaries

The team assembled at Central Rift Valley Water Works Development Agency Boardroom at 10:00am. The Chair called the meeting to order at 10:10 am with a prayer request by a volunteer. The chair requested teams from the Employer and the Prospective Bidders to introduce themselves.

Min 2/12/06/2023: Introduction

The chair made a brief introduction of the project and thanked everyone for finding time to attend the pre-bid site visit and informed them that it was of great importance that they attended as this would enable them to;

1. To have an understanding of the working environment and thus be knowledgeable when making decisions in preparing their bids.
2. Have an in depth understanding of the condition of the project site and location.
3. Clarify any issues/questions arising from the contractors.

Min 3/12/06/2023: Project Overview

The Chair welcomed the Project Engineer to make highlight the project scope.

The contractors were taken through the project overview by the Engineer as follows.

The location of the project is in Talai Location, Ewalel Chap Chap Ward, Baringo Central and Baringo South Constituencies in Baringo County. The site is approximately 170km from Nakuru the Agency Head Quarters and approximately 32km from Kabarnet the County Headquarters.

The project scope entails:

- i. Solarization of Kasau & Talai Primary School Boreholes
- ii. Fencing of Kasau and Talai Boreholes

- iii. Pipeline Extension from Kaptumo to Sogon Primary School
- iv. 2No elevated tower with 10,000 lts plastic tank
- v. 3No Water Collection Point
- vi. Sanitation facilities for Kaptumo & Sogon Primary Schools

The bidders were taken through the Eligibility Criteria and Qualification Criteria with in debt explanation on each item as follows.

- i. The submission of tender is as per the stipulation provided with adherence to 12.00 noon on 20th June 2023.
- ii. Bidders to ensure documents are serialized sequentially
- iii. Bidders to carry out arithmetic and error checks on their BOQ items since the Bid Sum submitted is final and cannot be altered
- iv. Bidders required to submit updated documents on experiences, financial, tax compliance, personnel, equipment and other relevant documents .
- v. Bidders to ensure the prices are competitive and within the market rates to avoid presence of abnormally low, abnormally high, unbalanced and front-loaded tenders as this will be subjected to further scrutiny and may result into disqualification of the bid if no justification is provided.
- vi. Bidders to avoid submission of fraudulent documents.
- vii. Bidders to familiarize themselves with the terrain and sources of materials.
- viii. Bidders to adhere to the requirements as indicated on Instruction to bidders viz a viz eligibility criteria. I.e The best evaluated tender will be the most responsive to the tender document and with the lowest evaluated price
- ix. The Agency will communicate each and every process through the Agency official communication channels and addresses as provided in the documents and as indicated below:

4	Solar Panel Brands	The Agency do not have a preferred supplier but the goods should have a warranty, meets the ISO Standards and the Energy (Solar Photovoltaic Systems) Regulations, 2020
5	Bidding for the two projects by same contractor Can special group apply for both?	Bidders were free to bid for the two projects in consideration with their technical and financial capacity. Yes: Special Group bidders are encouraged to apply for both tenders
6	Can the Engineers Estimate be shared?	NO: The Engineers estimate is a confidential document and therefore will not be shared. Bidders encouraged to carry out market survey and provide their market prices


